# FIRST AMENDMENT OF THE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR COTTAGES OF CATANIA IN WASHINGTON TOWNSHIP, ALLEN COUNTY, INDIANA

WHEREAS, North Eastern Development Corp. ("Declarant") executed and recorded the Declaration of Covenants, Conditions, Restrictions and Easements for Cottages of Catania platted at Document No. 2020049559 and Plat Cabinet H page 84 in the Allen County Recorder's Office (each individually a "Declaration" and collectively the "Declarations"); and

WHEREAS, pursuant to the Declarations including Section 7.29.2, the Declarant currently has the right to amend the Declarations; and

WHEREAS, capitalized terms as used herein shall have the same meaning ascribed to them or defined in the Declaration unless otherwise specifically defined herein.

NOW, THEREFORE, the Declarant hereby amends the Declaration as follows:

### 1. <u>AMENDMENT OF SECTION 7.10</u>

The second sentence of Section 7.10 in the Declaration for Cottages of Catania is deleted and removed from Section 7.10 of each of the Declarations (the "Deleted Sentences"). The Deleted Sentences in each of the Declarations are each replaced with the following new sentence: "Prohibited structures include, by way of illustration and not limitation, detached garage, shack storage and above ground pool, and in ground pools may be approved by the Architectural Control Committee."

#### 2. <u>MISCELLANOUS</u>.

Except as modified herein, the Declarations as amended by this First Amendment remains in full force and effect. This First Amendment and the Amended Sentence pertains to and only affects the first sentence in Section 7.10 of the Declarations for Cottages of Catania.
