In any event, no building shall be located nearer than a distance of 5 feet to an interior Lot line. No dwelling shall be located on an interior Lot nearer than 25 feet to the rear Lot line for lots 1 through 17, 27 through 39, and 51 through 71, and 15 feet for lots 18 through 26 and 40 through 50.
- 3. All other provisions off the Covenants not amended by this document shall remain in effect.

Lots numbered 1 through 7, 33, 34, 36 through 39, 65, 66 and 68 through 71, inclusive.
